Quotations are invited from individuals/ local dealers / agencies / Advertising Companies for advertising on the back side of CUSS (Self Check in) boarding pass.

The Quotation documents can be downloaded from the website of Kannur International Airport Limited (www.kannurairport.aero) under Tenders and Notification.

Benefits of advertising on back side of CUSS Boarding Pass:

One of the product/items through which advertisement can be done particularly inflight advertisement is boarding pass. Boarding pass is an important document that must be kept throughout the flight and in many companies/department boarding pass is considered as valid document for reimbursement of air travel fare also.

Through CUSS (Self check in) counters passengers are directly taking the boarding pass without any help of airline officials.

More than 50 % of the Current Domestic passengers of Kannur Airport are using the self-check in to collect the Boarding passes.

Major benefits of boarding pass advertisement are

- The large portion of the boarding pass is retained by the passenger till the completion of the journey and sometimes beyond, in case of airfare reimbursement.
- Therefore boarding pass is a good medium for advertisement and thereby marketing of product.

- The Boarding pass can be used as a marketing promotional device, like a coupon, which allows the company to measure the campaign response.
- The Air travelling public is having more time to go through the advertisement content.

In view of the above Kannur Airport offers an opportunity to advertise on our CUSS boarding passes, which will help to boost the number of potential customers for any product.

Terms and Condition

Designing of advertisement template to meet the boarding pass requirement is the responsibility of the licensee and shall be arranged by the licensee at his own cost to offer a pleasing design standard matching an International Airport standard.

The template shall be in single color and should match and meet the given dimension of the boarding pass. If the agency has submitted the sample in multicolor Kannur Airport has the right to convert to single color. [The dimension available for advertisement is 13 x 7 cm]

Objectionable contents in the display will not be permitted. Liquor and Tobacco brands will not be permitted. Kannur Airport also reserves the right not to allow any advertisement of certain contents which are objectionable and against the laid down law. The agency need to take prior approval of Kannur Airport for advertising content, color, size etc

Kannur Airport reserves the right to modify the template submitted by the agency to meet the requirement of Airport and boarding pass.

Only one template shall be accepted for 100 rolls. Any change in template after submission of the template to the printing agency shall not be accepted. For template change, if any, the cost towards the same shall be borne by the agency.

During the currency of the contract due to any administrative reasons/ any rules and regulations issued by the AERA/statutory agencies Kannur Airport may stop printing advertisement on the boarding pass and in such event no compensation can be claimed by the agency.

The successful bidder shall pay the quoted advertisement right charges/License Fee as per schedule of quantity. The amount quoted below the Minimum Reserved license fee (MRLF) will not be considered for evaluation.

The quoted license fee shall be exclusive of GST, Statutory levies, at the rates declared by Govt. of India/State Govt. /Local authorities from time to time. The successful tenderer shall pay the taxes as per actual.

Eligibility Criteria:

Any Firms or Individuals dealing with any product/services can apply. But the agency shall meet the following criteria

- a) Should have valid GST registration
- b) Should have PAN card in the company name
- c) Should have any establishment registered with appropriate authority

The self-attested copy of above to be submitted along with the offer.

Payment Terms:

- a) The agency shall submit 50 % of the quoted amount within one week from the date of issue of letter of award by NEFT/RTGS to the bank account of Kannur International Airport.
- b) Balance 50 % to be remitted after the approval of advertisement matter, but before starting printing.

Period of advertisement:

For a period of one year or consumption of 1,00,000 boarding pass (100 Roll paper) whichever is earlier. However on mutually agreed terms the license period can be extended also.

MRLF

Minimum Reserved license fee fixed by Kannur Airport is Rs. 2/- per Boarding pass ie. Rs. 2,00,000/- for 100 roller paper which can produce 1,00,000 boarding pass. The agency who quotes highest amount HI shall be considered for award of advertisement rights on the back side of CUSS boarding pass.

Paper Specification

The advertisement shall be on the back side of the printed boarding pass. The paper specification used for printing the boarding pass is given below.

1. **Paper Width and Roll Size:-**
 - a) Paper width is 203 mm +0/-1 mm (8.0 in. +0/-0.04 in.)
 - b) Outside diameter is between 152.4 and 203 mm (6 and 8 in.)
 - c) Inner diameter is 38.1 mm (1.5 in.)
 - d) Non top coated paper 0.086 mm (.0034 in.) caliper.
 - e) Advertising Area 130 x 70 mm or less.

Back side of the CUSS boarding pass shall be used for advertising (Annexure-1).
