NOTICE INVITING QUOTATION (NIQ)

Sealed quotations are invited in the office of the Head (Engineering), Kannur International Airport , Mattanur , Pin -670708 for the work of “Supply of KWA water including transportation facility for potable water at CISF Barrack, Valiyavelicham.”

The interested agencies may collect the prescribed quotation forms from 21/02/2024 to 27/02/2023 during office hours 10 AM to 5 PM, from the office of the Head – (Engineering), Kannur International Airport Limited, Kannur Airport (PO) , Pin -670708 or NIQ can be downloaded from the website www.kannurairport.aero.

Time Period: Work is for a duration of 6 months from the date of Work Order.

- i) Quotation shall be submitted on or before 28/02/2024 up to 14:00 Hrs. to the office of the Head (Engineering)), Kannur International Airport Limited, Kannur Airport (PO) , Pin -670708.

- ii) The Quotation will be opened on : 28/02/2024 at 1530Hrs

GENERAL TERMS AND CONDITIONS

1. The sealed cover containing quotation in duly filled in all aspects and super scribed as “Supply of KWA water including transportation facility for potable water at CISF Barrack, Valiyavelicham.” shall be deposited in the tender box kept at the Office of the Head (Engineering), Kannur International Airport Limited, Kannur Airport (PO) , Pin -670708.
2. The quotation document consists of Notice inviting Quotation, General rules, terms and conditions of contract and schedule of quantities. All these components form part of the quotation. It is obligatory on the part of the bidder to quotation and sign for all components parts.
3. The date of submission is up to 1400hrs on 28/02/2024 and shall be opened on the same day at 1530 hrs. The bidders can participate in the opening of quotations.
4. The bidder shall study the schedule of quantities and shall be deemed to have full knowledge of the items before quoting.
5. The intending bidder shall visit the site and make himself thoroughly acquainted with the local site condition, nature and requirement of works, facilities for transport, nature of labour required, access and storage of materials and removal of wastes etc. The bidder should quote taking into account all the site conditions including traffic restrictions for transport etc. for proper execution of work. The bidder will not be entitled to any claim of compensation for difficulties faced or losses incurred on account of any site condition.
6. The rate(s) must be quoted in decimal coinage. Amounts must be quoted in full rupees by ignoring fifty paisa and considering more than fifty paisa as rupee one.
7. The quoted amount shall be exclusive of GST.
8. The rate shall be quoted both in figures and words. If a discrepancy is found between the rates in figures and in words, then the rates which correspond with the amount worked out by the contractor shall unless otherwise proved be taken as correct. If the amount of an item is not worked out by the contractor or it does not correspond with the rates written either in figures or in words, then the rates quoted by the contractor in words shall be taken as correct. Where the rates quoted by the contractor in figures and words tally, but the amount is not worked out correctly, the rates quoted by the contractor will unless otherwise proved be taken as correct and not the amount. In the event no rate has been quoted for any items(s) leaving space both in figure(s) word(s), and amount blank,

it will be presumed that the contractor has included the cost of this /these items in other items and rate of such item will be considered as zero and work will be executed accordingly.

9. For any clarification/site inspection, Deputy Manager (Civil) may be contacted.
10. Unconditional acceptance letter is attached as Annexure-A which is to be signed and submitted along with the bid.
11. Schedule of Quantities is attached as Annexure B
12. The contractor shall ensure the safety requirements laid down by the local Authority and/or the National building code. The contractor shall be responsible and he should indemnify the Kannur International Airport for all injury/death to the workmen, person, animals, things or any other damage to the surrounding properties which may arise from the operations, carelessness, accident or neglect of himself or any of his workmen
13. KIAL reserves the right to accept or reject any or all application without assigning any reasons. KIAL also reserve the right to call of quotation process at any stage without assigning any reason.
14. **Terms of payment:**
 - Payment after statutory deductions will be made on monthly basis for the work.
 - No price escalation will be accepted under any circumstances on the quoted price.
15. **Documents to be submitted along with the Quotation**
 - Unconditional Acceptance letter
 - Documentary proof (Xerox copy) of PAN card
 - NIQ document duly sealed and signed
 - Financial bid (Annexure B)
 - Envelope shall be super scribed as “Supply of KWA water including transportation facility for potable water at CISF Barrack, Valiyavelicham.”
16. The work shall be commenced in 2 days from the date of award and is for a period of 6 months, but time period is extendable with same terms & conditions as per the discretion of KIAL management.
17. The quotation Accepting Authority shall be the Managing Director, KIAL.
18. If there are varying or conflicting provisions made in any one document forming the part of the contract, the accepting Authority shall be the deciding Authority with regard to

the intention of the document and his decision shall be final and binding on the Contractor.

19. The agency should have to make payment to Kerala Water Authority and documentary proof of payment shall be submitted to KIAL. The coupons from KWA office Thalassery has to be collected by the contractor.
20. The quoted rate shall be inclusive of the water charge to KWA and the transportation charge.
21. The water test certificate from KWA shall be submitted to KIAL on quarterly basis.
22. The water shall be drawn from KWA sump near Valiyavelicham approximately 1.2 Km away from the barrack.
23. If water is not available at the said sump, water has to be arranged from some other source by the contractor and payment of the same shall be at a mutually agreed rate. If so, the water test certificate of the alternate source shall be submitted by the contractor.
24. If the capacity of the tanker is more/ less than 5000L, the trip calculation will be made in prorata basis.
25. The water collected from the KWA sump has to be pumped into the overhead tank at CISF barrack and no wastage should occur.
