# NOTICE INVITING QUOTATION

# Name of works: Supply of Mattresses at CISF Barracks, Valiyavelicham-reg

Sealed quotations are invited by Managing Director, Kannur International Airport Limited from Manufacturers/Authorised Dealers for "Supply of Mattresses at CISF Barracks, Valiyavelicham" who meet the following criteria:-

- 1. Offered mattress shall have a warranty of 3 years
- 2. Shall have GST Registration Certificate
- 3. Shall have PAN Card.

# GENERAL TERMS AND CONDITIONS OF CONTRACT:

The agency should submit their sealed quotation in two cover system (Two Envelop Systems)

- Envelope A-Technical Bid
- Envelope B-Price Bid.

Duly signed, stamped and sealed Bids will be submitted in the following pattern:-

### Envelope A- (TECHNICAL BID):

To be super scribed on Envelope A as "Technical Bid for Supply of Mattresses at CISF Barracks, Valiyavelicham".

The envelope should contain the following documents / details:-

- 1. Documents showing the participants are Manufacturers/Authorised Dealers of the offered mattress.
- 2. Technical Brochures, Technical Specification sheet of mattress offered by the bidder in reference to Specifications enclosed as **Annexure-I**.
- 3. Copy of GST Registration Certificate & PAN Card.
- 4. Warranty details of product offered which shall be at least for a period of **three years** after supply.
- 5. Duly signed copy of Unconditional Acceptance letter at Annexure II.



### Envelop-B (PRICE BID)

To be super-scribed as "Price bid for Supply of Mattresses at CISF Barracks, Valiyavelicham" and shall contain price Bid duly filled, stamped and signed in the given format as per Annexure-III.

### Any deviation from the format will not be accepted.

Technical Bid (Envelope-A) and the Price Bid (Envelope-B) will be opened on the same date. Technical Bid will be opened first and the price bid will be opened for those party/agency only whose Technical Bid is accepted by Kannur Airport on satisfaction of documents mentioned under Envelope-A.

#### TERMS AND CONDITIONS:

#### 1. Rates

- 1. Rates quoted shall be excluding GST and inclusive of all taxes, duties & levies, packing, loading & unloading and transportation charges, transit insurance etc. for delivery at CISF Barracks, Valiyavelicham, Kuthuparamba. GST shall be paid extra.
- 2. Validity of Quotation: The offer shall be valid for a period of 90 days from the date of opening of quotation.
- 3. Kannur International Airport is not responsible any postal delay in receipt of quotation. The bidder should ensure that the quotation reaches on or before the due date and time.
- 4. The mattress shall be covered by a **three-year warranty** from the date of delivery at CISF Barracks and its subsequent acceptance by KIAL/CISF committee. The supplier shall provide warranty coverage for the mattress within Kannur district.
- 5. Quality Check: The supplier shall provide one mattress in excess of the quantity specified in the bill of quantities at no additional cost. A randomly selected mattress from the supplied lot will be inspected by a committee comprising representatives from KIAL/CISF. The cover of the selected mattress will be opened in the committee's presence, and the material inside will be inspected to ensure compliance with the specifications outlined in this notice inviting quotation. The supplier shall take back the inspected mattress at no additional cost, and payment will be made only for the quantities specified in the bill of quantities. The supplier shall take back the inspected mattress at no additional cost, and payment shall be made only for the quantities.



If, during inspection, the mattress is found not to meet the required specifications, the entire lot shall be deemed non-compliant and rejected by Kannur Airport. The supplier shall take back the entire lot at no extra cost and provide a fresh lot at the site.

6. **Payment Terms:** 100% payment shall be released by Kannur Airport after supply of the material to the consignee subject to deductions/recoveries (if any) towards TDS etc. There shall be no advance payment for this work.

The payment will be released by Kannur Airport subject to the submission of the following documents:

- a) Signed Commercial Invoice in original (Two Copies)
- b) Guarantee/Warranty certificate
- 7. **Time Period of Completion:** The period for completion of supply of the materials at CISF Barracks, Valiyavelicham, Kuthuparamba shall be **60 days** which shall be reckoned from the date of purchase order issued by KIAL.
- 8. **Delays & Non-conformance:** In case of delivery schedule originally agreed upon by Kannur Airport and not being adhered to by the supplier, the following procedure shall be applicable.
  - a) The supplier shall give reason for delays and apply for extension of delivery period.

b) Kannur Airport may extend the delivery period without liquidated damages if the reason given by the supplier are found justified. Otherwise, delivery period may be extended with levy of liquidated damage @1% of the value of undelivered stores per week of delay subject to maximum of 10% of contract value. Part of a week shall be treated as one whole week.

6. Taxes: All Taxes shall be as applicable in GST regime. Payment of CGST, SGST, IGST & UTGST: The suppliers are required to adhere the following procedure in order to honour the payment against CGST, SGST, IGST & UTGST in the invoice.

The rates along with Brochures, Drawing, Specifications, NIQ documents and other technical details of the product should be sent in a sealed envelope, super scribing on the top "Supply of Mattresses at CISF Barrack, Valiyavelicham," to the Chief Security Officer, Kannur International Airport, Kannur International Airport PO, Mattanur, Kannur - Pin 670708, on or before 06.03.2025 up to 1500 Hrs. The sealed quotations will be opened on the same day i.e. on 06.03.2025 at 1530 Hrs. Interested participants may remain present during quotation opening.
