3. The quoted rates shall be firm on F.O.R. Mattannur Project/annexe Office basis and inclusive of all taxes, duties etc, such as excise duty, customs duty, sales tax, octroi, freights, insurance, VAT, Service tax etc as applicable. No extra claim shall be entertained in this connection.
4. On satisfactory supply of the item, final bill shall be submitted by you to the Project Engineer and the same shall be processed with the following documents:
 - a. Your final bill
 - b. Certificate of completion of work issued by the Project Engineer
 - c. Other relevant documents, such as warranty certificates, manuals, etc.
5. **TERMS OF PAYMENT**

100% payment shall be made to the supplier by KIAL on satisfactory supply of the item, after making statutory deductions and any dues which the supplier may become liable.
6. **COMPLETION PERIOD**

The work shall be completed in all respects within **15 days** which shall recon from the day of placement of work order.
7. **ENGINEER-IN-CHARGE**
