Per the suggestions received, some of the clauses have been changed as below:

Bank account statement in country of residence, duly attested by Bank under its seal duly verified and attested by Notary/Apostille in that country 2. If an Individual is representing the Bidder, an Authorization on company's letter head.

3. The bidder should have a branch office or liaison office in India for coordinating the activities in India with a duly executed power of Attorney from the Foreign principal to bind the principal.
4. The bidder should furnish the document of incorporation duly apostalised by a notary.
5. The bidder should furnish audited financial statements of the bidder for the three preceding financial years duly certified by the Chartered Accountant/ Public Accountant as per the law of country.

c) Following requirements shall apply to all the Bidders:

The Bidder shall verify the antecedents and loyalty of representatives, agents, employees and workmen before employing them on the work. Bidder shall ensure that no person of doubtful antecedent and nationality is in any way associated with the Works. The background verification reports should be provided to Kannur Airport upon request. Any Foreign nationals shall be engaged only as per the regulations and guidelines of Bureau of Civil Aviation Security (BCAS) and Govt. of India.

All other conditions remain same.
